### LOAD RITE Elite Series

### 2 Plus 3 Years Coupler to Taillight Warranty

LOAD RITE Trailers, Inc. (LOAD RITE) warrants each new LOAD RITE Elite Series trailer it manufactures to be free from defects in materials and workmanship. LOAD RITE will cover all frame and structural components for five (5) years and all other components for a period of two (2) years, except as noted below, from the date of purchase by the original consumer or three (3) years from the date of manufacture, whichever comes first.

Load Rite's "Coupler to Taillight" warranty is for two (2) years from date of purchase by the original consumer. This warranty covers all components except tires (covered by the tire manufacturer under a separate warranty included in your Owner's Packet), and wear items. This limited warranty is not transferrable.

For five (5) years from the date of purchase by the original consumer this warranty covers the structural components which include the frame rails, crossbars, tongue, winch post, bunk brackets, roller brackets, pivot bars, and axle weldment to be free from defects in materials and workmanship. Due to the harsh and highly corrosive operating conditions to which a boat trailer is exposed, rust formation, galvanizing and/or finish, and alignment are not covered. This limited warranty is not transferrable.

LOAD RITE will repair or replace, at its option, without charge, any parts found to be defective due to defects in material or manufacturing when the parts and/or trailer are returned at consumer's expense to an Authorized LOAD RITE Dealer or authorized repair center as designated by LOAD RITE. Pre-Authorization is required for all warranty work. This limited warranty is not transferrable.

Provisions of this warranty shall not apply to any trailer or component that is found to be modified or altered in any way from its originally shipped condition. This warranty does not cover damage, defect or malfunction caused by Acts of God, riot, war, unreasonable use or failure to perform reasonable and necessary maintenance. This warranty does not cover damage, defect or malfunction caused by misuse, overloading the trailer beyond stated capacities, improper adjustment of the trailer to the boat, or the use of weight distribution hitches in conjunction with hydraulic surge brakes, as well as improper use or use beyond the design limitations of the trailer. Trailers used as part of a rental fleet or for a commercial purpose are not covered by this consumer warranty.

Certain components on LOAD RITE trailers are considered wear items including, but not limited to: tires; bearings; seals and races; brake friction surfaces; and bunk carpet. These items must be inspected, maintained and replaced by the owner as necessary. Bearings and seals are covered for 120 days from date of purchase.

ANY IMPLIED WARRANTIES, OBLIGATIONS OR LIABILITIES, INCLUDING BUT NOT LIMITED TO, AND IMPLIED WARRANTY OF MERCHANTABILITY OR FITNESS FOR PURPOSE, SHALL BE LIMITED TO THE TERM OF THIS WRITTEN WARRANTY. LOAD RITE TRAILERS, INC. SHALL NOT BE LIABLE FOR ANY INCIDENTAL OR CONSEQUENTIAL DAMAGES FOR BREACH OF THIS OR ANY OTHER WARRANTY, EXPRESSED OR IMPLIED.

No transportation charges or related expenses (such as loss of time, inconvenience, travel expenses, lodging, telephone, gas, towing charges, loss or damages to personal property or loss of wages) are covered by this warranty.

This warranty complies with the "Magnusson-Moss Warranty Federal Trade Commission Improvement Act" limited warranty provisions and any provisions of this warranty or actions taken by LOAD RITE pursuant to this warranty shall be construed accordingly. This warranty gives you specific legal rights and you may also have other rights which vary from state to state.

This warranty is validated by the submission of the Warranty Registration card included below OR by the completion of the Warranty Registration through other various electronic means as provided by LOAD RITE Trailers, Inc. It is the responsibility of the original purchaser to submit this warranty within 90 days from the date of purchase. Failure to submit this notification within the time provided will relieve LOAD RITE Trailers, Inc. from any responsibility under this warranty.

## ON THE ROAD TO PROPERLY MAINTAINING YOUR *LOAD RITE* TRAILER:

Refer to your Owner's Manual and [www.loadrite.com/resources/documents/](http://www.loadrite.com/resources/documents/) for even more maintenance information.

*LOAD RITE* recommends **regular** maintenance **during the boating season** as follows:

- ◆ Lights, wiring, coupler action, safety cables, winch cable, and lug nut torque should be inspected **before each use**.
- ◆ Recommended lubricant, NLGI #2 EP lithium complex based high temperature wheel bearing grease, should be applied via the grease fitting on or within the hub bearing cover or on the hub itself **after each submersion** in water of a warm hub, **or monthly, whichever comes first**. The rapid cooling effect of the water could promote water permeation past the wheel seals. Application of grease is intended to displace any water drawn in upon cooling.
- ◆ All fasteners should be checked for proper tension. All roller assemblies, winches, and tongue jacks should be checked for free movement and lubricated as necessary.
- ◆ Drum brakes should be adjusted. See the latest procedure at [www.loadrite.com/resources/documents/](http://www.loadrite.com/resources/documents/).
- ◆ Disc brakes require no adjustment. However, they require periodic maintenance. See the latest documentation at [www.loadrite.com/resources/documents/](http://www.loadrite.com/resources/documents/).

Recommended **annual maintenance should be performed before winter storage** is to **include all of the above in addition to** the following:

- ◆ Annual maintenance should involve the disassembly, cleaning, inspection, and repacking of all wheel bearings with the recommended lubricant, NLGI #2 EP lithium complex based high temperature wheel bearing grease. It is recommended the inner seal and retaining hardware be replaced any time the hub assembly is removed from the trailer. Bearings and races should be replaced when exhibiting wear or discoloration.
- ◆ All moving parts within the brake drum and sliding points on the brake caliper should be inspected for wear and free movement, and lubricated as needed. Brake shoes or pads should be inspected to assure they are clean, dry, free of any contaminants, and not worn below their serviceable limit. Serviceable limit is commonly considered 3/32" from top of rivet to pad surface.
- ◆ **Brake fluid should be thoroughly bled annually and replaced with fresh DOT 3 from a previously unopened container.**
- ◆ All fasteners should be checked for proper tension. All roller assemblies, winches, and tongue jacks should be checked for free movement and lubricated as necessary. Bunk boards should be checked for internal integrity.

Frames and axles should be visually inspected for rust, damage, and fractures. *LOAD RITE* recommends replacement of any structural member having been stressed beyond its range of intended service.
